## The owner(s) of stud is making the agreement with the owner(s) of said bitch as follows:

- The Stud Dog Owner is offering the stud service for the fee of \$1000.00 to be paid before service.
- Should the Bitch fail to conceive, the Stud Dog Owners will provide one repeat stud service to this Bitch or an agreed-upon bitch owned by the same owners, unless the Bitch Owner failed to obtain multiple progesterone testing on the Bitch, in which case there will be no repeat breeding provided without an additional Stud Fee. If the bitch fails to conceive and the method of insemination was "regular" AI, No repeat breeding will be given unless bitch owner agrees to a surgical or trans cervical implant. In the case of a substitute bitch, all requirements of this original Agreement must be met. In the event that the Bitch changes ownership, there is no obligation on the part of the Stud Dog Owners to provide repeat service.
- Repeat Breeding is to be within one year of original breeding.
- ONE (1) live puppies are considered a litter and would fulfill this agreement.
- The Stud Dog Owner agrees to complete the AKC litter registration within 72 hours of being notified the bitch owner(s) have started the registration process. The owner(s) of the bitch are responsible for contacting the stud owner(s) within 72 hours of the birth of the litter with the following information: the size of the litter, sex of living puppies, and color of puppies.

# The owner(s) of said bitch is making the agreement with the owner(s) of stud as follows:

- The Bitch Owner(s) agree to pay for any and all semen shipping charges and will agree to return shipping containers (and contents) in a timely manner to Stud dog owner. Failure to return shipping containers will result in a charge for the replacement costs of a similar shipping container and a delay of litter registration until the replacement charges are paid in full.
- The Bitch Owner(s) agrees that puppies resulting from this breeding shall not knowingly be sold either directly, or to an agent thereof, who sells outright or consigns to a pet shop, kennel, or individual whose purpose is mass production, wholesaling, or retailing of purebred dogs. Furthermore, the owner(s) of said bitch agrees that all puppies resulting from this mating which are not to remain under the ownership of bitch owner(s) will be sold on limited registration or spay/neuter agreements.
- The Bitch Owner(s) agrees to notify the stud owner(s) within 70 days of the breeding if no puppies are produced from this breeding and a rebreeding is necessary. If the stud owner(s) are not notified within 70 days the rebreeding guarantee is null and void.
- Bitch may have no disqualifying faults per the Breed Standard, and all genetic and/or health problems which exist or have existed in the bitch must be disclosed to Stud Dog Owners before the breeding.
- Bitch Owner warrants that Bitch who is the subject of this contract has not been and will not be exposed to any other stud dog from the start of her heat cycle.

The invalidity of any portion or section of this contract shall not affect the remaining portions.

A waiver of any portion or section of this contract shall not be construed as a waiver of any other provision or provisions.

If any stipulation of this contract, in whole or in part, is not fulfilled as agreed and Bitch Owner(s) is found to be in Breach of Contract. Then they shall be responsible for a fee and penalty not less then, but not limited to \$2800.00 per occurrence.

#### **CERTIFICATION**

This contract shall be deemed a legally binding contract and is under the jurisdiction of the State of Utah and the county of Davis. It is further agreed that any disputes regarding this contract shall be made in the County of Davis, UT.
